Entity Regulation and Regulatory Reform Overview

A history of the Entity Regulation Pilot Project was given to the Board.

Innovation for Providing Legal Services

Entity Regulation Pilot Project Update:

1. Application Launch

- The application portal will open on October 21st.
- A link to the participant manual is now available on the website.

• The application form is also linked on the site. Currently, users can browse the form but will not be able to submit until the 21st.

2. Communication & Outreach

- Discussion on identifying the next audience for outreach efforts.
- Brainstorming began on potential informational videos to support applicants and raise awareness.

3. Next Phase

- The upcoming phase will focus on receiving and analyzing applications.
- It is currently unclear how many entities are ready to apply, though there is known interest from organizations in Utah (UT) and Arizona (AZ).
- A fact sheet for the pilot project was briefly discussed and noted that there is one on the WSBA website.

Unauthorized Practice of Law Complaints Summary

A summary of UPL complaints received and referred was presented to and reviewed by the Board.

Education Committee

Michael informed the Board that two meetings of the Education Committee have been held so far, and participation remains open for others to join. The committee is currently focusing on 2–3 top priority projects. One project is creating a website or webpage for the public for centralized and enhanced access to educational materials. Another goal is to improve the usability of the legal directory, making it easier for the public to navigate and find relevant legal resources. The group discussed strategies to fulfill the mandate under GR 25(b)(1), which emphasizes educating the public on how to find legal assistance. The focus is not only on locating a lawyer but also on helping individuals evaluate legal professionals and understand what to expect when working with one.
