#### IV. NWDR Conference Updates/Conversation

Melissa wants to start outreach for speakers. The committee is working on the Shaw Events contract. They did an amazing job for the 2024 conference. They also helped the planning committee learn and develop. Melissa recommends we use them again and try to double the registration from last year.

Paula is working on a logo for the conference. She said the 2024 contract with Shaw was modeled off the 2019 contract with the UW. Paula did some market research and with 250 attendees, the range for the event planner is \$18-40K. Kristin said her absolute floor would be \$22K if we want a flat rate. Paula likes a contract where Kristin has skin in the game.

Ted also looked into what a competitive rate might be. He asked a friend who does these things and found out that it is typically either a flat fee or cost plus profit and the profit can range from 20-50%. He thinks since Shaw has performed so well that their contract is in the ballpark. It may be the high end but it is justified in terms of performance.

Carolyn has the draft contract and will move forward with it. The Committee approved her action unanimously.
