- Midyear will be at Suncadia next year and will budget accordingly. Deficit of \$3500 expected for 2018, but we can adjust as it gets closer. Still, may need to this year after midyear; adjust numbers down for next year to anticipate higher expenses (potentially \$0).
- Mini CLE revenue budgeted \$500 last year, received \$315. Will likely revise down for next year.
- In general, section is under budget for the year in terms of expenses and doesn't look like we will go over.
- Lisa and Elizabeth will work to finalize budget and get back to Joe by July 19.
- New treasurer still need a volunteer.
