Women, War and Collective Security Wednesday December 17, 2008

On Wednesday, December 17, 2008, the section presents "*Women and Collective Security*," a half-day program featuring several distinguished speakers, at the WSBA Offices, 1325 4th Ave., Ste. 600, Seattle. Registration starts at 12:30; the program runs from 1 p.m.-5 p.m. Because our year-end programs almost always fill up, please pre-register to avoid disappointment.

Faculty: Moni T. Law, lawyer and WSBA bar leaders program manager, will open the seminar with a twenty-minute film that she produced, *"Female Faces of War."* The film reveals the impact of the Iraq war on women, featuring an American female soldier, an Iraqi woman who advocates for refugees, a female veteran who advocates for veterans and a mother whose son was killed in the war). Ms. Law will briefly cover major international human rights treaties which protect the rights of women and girls, including the International Covenant on Civil and Political Rights, the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW), and the Convention on the Rights of the Child.

The film will be followed by two highly regarded speakers. **Professor Nada Elia** is a professor of gender and global studies at Antioch University. She is the president of the Association of Middle East Women's Studies, the founding member of the National Council of Arab-Americans, and is on the Editorial Advisory Board of the Journal of Middle East Women's Studies. Professor Elia is currently at work on a second book on women's activism in the 21st century.

The program also features **Professor Won Kidane**, assistant professor of law at the Seattle University School of Law, who teaches and writes in the areas of immigration law, administrative law, and international and comparative law. Before joining the Seattle University Law School, Professor Kidane taught at the Penn State Dickinson School of Law, and worked as a legal officer in association with the African regional office of the United Nations High Commissioner for Refugees (UNHCR), where his duties included refugee status determination, and the protection of rights of refugees.
