Section Annual Report for 2010

1.Section highlights and accomplishments in 2010

- a. From January-July proposed and lobbied BOG to approve a resolution supporting ratification of the Convention on the Rights of the Child (CRC), originally adopted by Section in 12/09; received support from International Practice and Juvenile Law Sections, family law practitioner Rita Bender and National Lawyers Guild, Seattle Chapter.
- b. Offered mini CLEs with highly qualified and engaging speakers on a range of human rights, environmental and disarmament issues, in January, March, April, May, September and October.
- c. Held two meetings to discuss international law issues of Gaza Flotilla Incident of 5/31/10 in context of Israel-Palestine conflict and Middle East peace.
- d. Cooperated with community groups concerned with international rule of law and nuclear disarmament: worked with two NGOs to co-sponsor a forum and to bring an expert to speak (League of Women Voters and Peace Action).
- e. Increased number of members.
- f. Increased member participation in activities, appealed to new and young members; continued building more diverse leadership; participated in WYLD Sections Night.
- g. Completed Bylaws Restatement and Amendments (started in 2008) for submission to BOG.
- h. Published monthly newsletters and used newsletters to amplify topics of mini CLEs.
- i. Developed and conducted a survey of members; held meetings on Section's mission. and Section's use of electronic communications.
- j. Initiated new working relationships with faculty at all WA law schools on CRC Resolution.

2. Priorities for upcoming membership year 2011

- a. Continue mini CLEs on a frequent basis, at least 6/year.
- b. Analyze results from member survey (done December 2010) and make needed changes.
- c. Continue activities, relationship building with Washington law schools and other organizations to promote the 7/10 WSBA resolution on the Convention on the Rights of the Child.
- d. Hold informal meetings on public international law issues of interest to members.
- e. Expand membership, increase membership participation, recruit and develop WPTL leadership.
- f. Develop relationship with WYLD through newly assigned WYLD liaison to WPTL and increase cooperation with other WSBA sections and legal organizations.

3. Current benefits for Section members

- a. Free mini CLEs and public international law issue sessions.

- c. List serve.
- d. Website.
- e. Networking opportunities with Section members.

4. Section interactions with WSBA staff and the Board of Governors

The two section liaisons have provided prompt, high-quality and courteous service. BOG liaison Moore has been very accessible, capable and rendered important assistance, as did Governors Silverman, Kerr, Etengoff and Leishman, in the processing of the Section's CRC resolution.

The withdrawal of the ability to use WSBA offices for mini CLEs has adversely affected the WPTL.
