About the Board of Bar Examiners and the Washington Bar Examination

The Board of Bar Examiners grades the Multistate Essay Examination (MEE) and the Multistate Performance Test (MPT) answers for the Uniform Bar Examination (UBE) and produces the content for the Washington Law Component test under the direction of the Board of Governors, in accordance with the Admission and Practice Rules as approved by the Washington Supreme Court.

The UBE is administered over two days, consisting of six MEE questions and two MPT questions on the first day, and the Multistate Bar Exam (MBE) on the second day. The MBE is a multiple-choice exam. The MBE is scored by the National Conference of Bar Examiners and the MEE and MPT are graded by the Board of Bar Examiners. The grading is completed over the course of one long weekend at a grading conference held in mid-March and mid-August in Seattle. After the grading conference, the MEE and MPT scores are scaled to the MBE, with the MBE weighted 50%, the MEE 30%, and the MPT 20%.

The winter exam requires a total of 10 examiners to grade the MEE and MPT and the summer exam requires a total of 18 examiners. Each examiner must attend the mandatory scheduled NCBE grading workshop in person, by teleconference, or by review of the conference video prior to grading the exams.

The Washington Law Component (WLC) consists of 15 subject matter outlines and related multiple choice questions covering the following topics: Administrative Law, Civil Procedure, Statute of Limitations and Washington Courts, Community Property and Domestic Partnerships, Constitutional Law, Consumer Protection Act, Criminal Law and Procedure, Evidence, Foreclosure and Limited Practice Officers, Indian Law, Land Use, Landlord Tenant Law, Public Records Act, Torts and Product Liability, The WLC educates applicants about areas of law that are unique to Washington or substantially different from the general law covered on the UBE. The WLC includes an online, open-book test that applicants must pass with a score of 80% or higher prior to admission to practice law. The Board of Bar Examiners reviews and edits the outlines and test questions on a regular schedule.

Reimbursement policy: Reasonable travel expenses may be reimbursed per the WSBA Expense Reimbursement Policy.

Selection and appointment process: Candidates are vetted by a nomination team including the Board chair and vice-chair, staff liaison and the liaison from the Board of Governors. The Board of Governors makes the appointments.
